### CALL FOR PAPER

The 13th edition of the Women in Logistics Forum 2025 as an International Conference will take place in Gdańsk (Poland) from May 12<sup>th</sup> – 13<sup>th</sup> 2025 at the Gdańsk Shipyard (Elektryków Str.).

The conference will host a scientific session where working papers can be presented. The scientific session will be held on Tuesday 13<sup>th</sup> May 2025 from 09.30 until 12.30 in the hybrid form (stationary + online) at the University of Gdańsk.

### Full Paper Submission Guidelines

Full paper guidelines

Please follow these guidelines. Please DO NOT submit papers as PDF files. Please submit your paper in (Word - .docx format) to the following email address: [beata.trochymiak@kobietywlogistyce.pl](mailto:beata.trochymiak@kobietywlogistyce.pl)

- *Abstract*

The abstract must provide a comprehensive summary of the final paper submitted and it have to be include: Purpose, Research Approach, Findings, Originality and Research Impact and 6 Keywords

Please keep the abstract to a maximum of one (1) page of A4.

- *Length of the paper*

The length of full papers is restricted to 8 pages of A4.

- *Contents*

The paper must begin with the title, followed by a blank line and then the authors' names with affiliations(s) on the following lines. This should be followed by the main text. The main text should begin with a short introduction followed by a review of relevant literature, a description of the problem or challenge, the research work, results/analysis, discussion and conclusions. References should be included and placed after the conclusions.

- *Fonts*

Please use Times New Roman 12pt bold for the paper title and Times New Roman 11pt for the text, tables and fixtures. All section heads are to be in Times New Roman 12pt bold and underlined. Sub-headings are to be in Times New Roman 11pt bold. A blank line should appear at the end of each section.

- *Margins and Paper*

Paper size is A4 with all margins set at 2.5cm (top, bottom, left and right.) Text, figures and tables should not appear outside these margins. Paragraphs should be fully justified.

- *Spaces and Paragraphs*

Please do not use the tab key for paragraphs. Always use a line to separate paragraphs, headings, subheadings, tables and figures.

- *Figures and Tables*

Figures and tables should be integrated into the text. Numbers and associated text should be Times New Roman 11pt centred and placed underneath the table or figure

- *References*

References should appear in the text as illustrated in the following piece of text taken from a paper by Hines, Holweg and Sullivan (1999):

‘...According to established rhythmic beach geomorphology theory there are two possible causes for the cusps (Pethick, 1984). We will follow the theory expounded by Keunen (1948). Within this theory...’

The reference sections should hold the references, bulleted in alphabetic order.

- *Language*

All papers must be written in English and Conference presentations are to be delivered in English.
