Political violence, civil unrest, economic crises, and natural disasters have occurred at a constant pace, leading to an ongoing global crisis of refugees and other forced immigrants and migrants, i.e. (im)migrants. The infrastructures, capacities, and policies necessary to address the needs of refugee youth, their families, and their communities are strained in host countries and receiving communities worldwide. *Education for Refugees and Forced (Im)Migrants Across Time and Context* follows the journey of refugee and forced (im)migrant youths as their educational needs and opportunities vary according to resettlement communities' immigration policies, dominant culture and language, geography, and other key factors.

There is little research around the transition from peri- to post-migration education of refugee youth across time and context. Chapter authors address that gap by examining the conditions of refugee youth across different types of refugee contexts, including violence/conflict, natural disaster, economic crisis, political oppression, and how educational expectations, opportunities, and experiences shift before, during, and after the forced (im)migration journey.

Synopsis

The First British Crime Survey: An Ethnology of Criminology within Government explores the early history of the British Crime Survey, now the Crime Survey for England & Wales, a research enterprise widely perceived to be an international gold standard for the measurement of crime.

Over the past forty years, the survey has reshaped public debate with new insights into patterns of crime and perceptions of the criminal justice system. Currently, the administrative origins of the survey can be traced to the growing influence of an international network of criminologists and public officials focused on crime prevention and measurement, the organisation of Home Office research programmes, and public officials' concerns about urban uprisings, efficiency reforms, media coverage, and the politics of crime.

The First British Crime Survey: An Ethnology of Criminology within Government examines the history of this survey through the work practices of the 'crime survey circus' which developed new methods for counting and reporting crime. Julian Molina provides a novel contribution to the understanding of how government officials, academics, and 'administrative criminologists' address the practical challenges associated with new, large-scale data projects. This ethnography draws on archival sources, interviews with government officials and criminologists, and the author's experience using survey data within government.

A crucial resource for understanding the history of the British Crime Survey, *The First British Crime Survey: An Ethnology of Criminology within Government* appeals to those interested in the relations between 'law and order' politics, crime statistics, administrative criminology, and the criminal justice system.


